# 3. Purposes

We will not process more data than is strictly necessary to fulfill the purpose for which data is collected. We handle the information collected with care. Data is never made available to third parties for commercial purposes.

#### **Contact**

If you have contacted us, by telephone, email, contact form, the download section on our site, or social media, then we've received information from you. We process this in order to respond to your message or request. If you have contacted us via social media, this will usually be via Annemieke's personal account. This then concerns private or domestic use.

### **Newsletter**

We like sharing a newsletter if you are a client or if you have subscribed to the newsletter. We process your name and email address, so we can share information and inform you about changes to products and/or services. If you subscribe for the newsletter, your e-mail address is automatically added to the list of subscribers. In our newsletter, a link allows you to unsubscribe from the newsletter at any time.

### Payments, proposals, assignments and invoicing

When you purchase a product on our website, your contact info for receiving the product or service, and payment details like your bank and account number, is shared with us. If you have given us an assignment or we deliver a service, we process data necessary for the execution of that assignment or service. In any case, this is your name and email address and the information that is necessary for us to send a correct invoice. When payment is made, we will also be shown which account this is from and who the account holder is. Besides creating proposals and invoices, we need data to execute an assignment well. In this case, we process and save that data for the duration of our agreement.
